ORDINANCE NO. 2019 -37

AN ORDINANCE AUTHORIZING AN EXPANDED STREET CLOSINGS FOR WIZARDLY WORLD OF KENT THAT WILL BE HELD ON SATURDAY, JULY 27, 2019, AND TO PROVIDE 48 HOUR NOTIFICATION OF THE STREET CLOSINGS TO ALL RESIDENTS, AND DECLARING AN EMERGENCY.

WHEREAS, for the past three years, the City has granted Main Street Kent, an Ohio nonprofit corporation, street closings for its Wizardly World of Kent (formerly Potterfest); and

WHEREAS, Main Street Kent requests expanding those street closings for North Water Street, from Main Street to Portage Street, to better accommodate pedestrian flow and access to vendor events, as shown in the attached Exhibit, and to provide 48 hour notification of the street closings to all residents; and

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio, at least three-fourths (3/4) of all members elected thereto concurring that:

SECTION 1. Council does hereby authorize the street closings shown in the attached Exhibit for the Wizardly World of Kent being held on Saturday, July 27, 2019, and to provide 48 hour notification of the street closings to all residents;

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.


