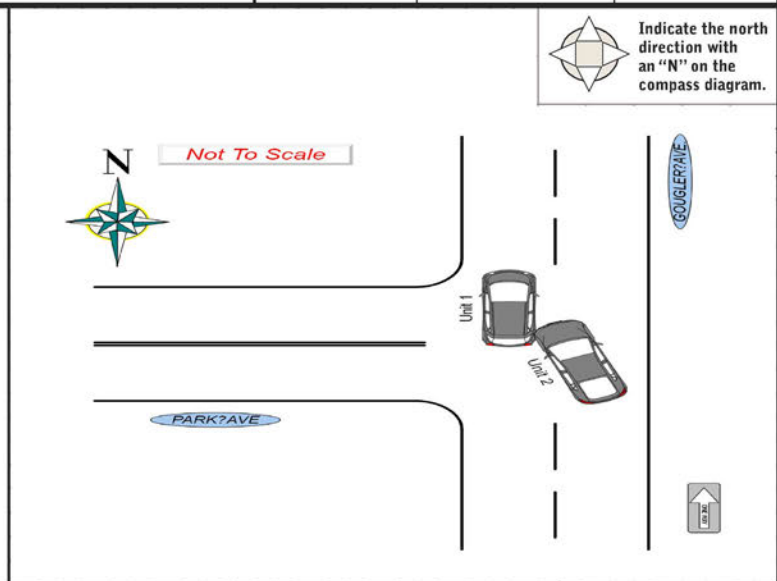

UNIT 1 AND 2 WERE TRAVELING N/B ON GOUGLER AVE. AT PARK AVE. UNIT 1 IN THE LEFT LANE, UNIT 2 IN THE RIGHT LANE. UNIT 2 ATTEMPTED TO MAKE A LEFT TURN ONTO W/B PARK AVE. UNIT 2 FAILED TO LEAVE ASSURED CLEAR DISTANCE WITH UNIT 1. UNIT 2 STRUCK UNIT 1, CAUSING A 2 VEHICLE CRASH. UNIT 2 WAS AT FAULT FOR THE COLLISION. LATER THE DRIVER OF UNIT 1 COMPLAINED OF A NECK INJURY POINTING TO HER RIG SIDE OF HER NECK.

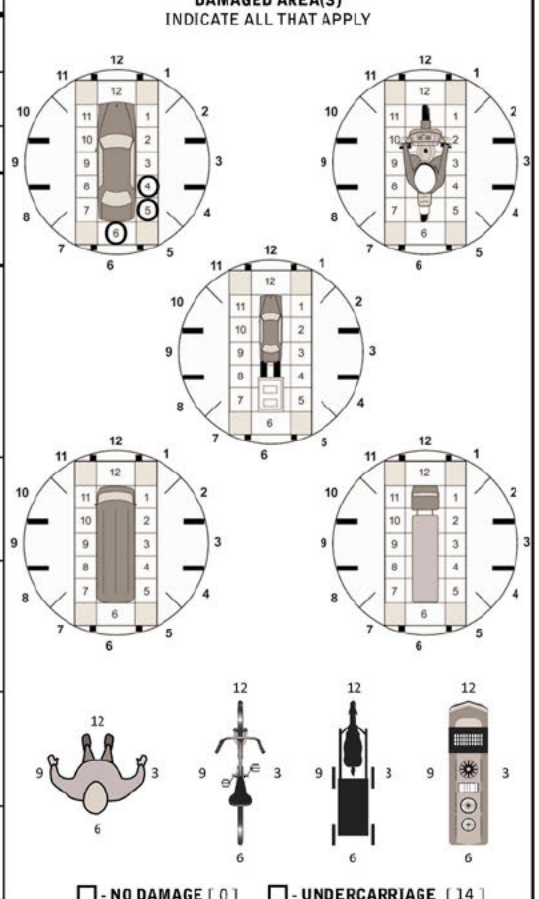

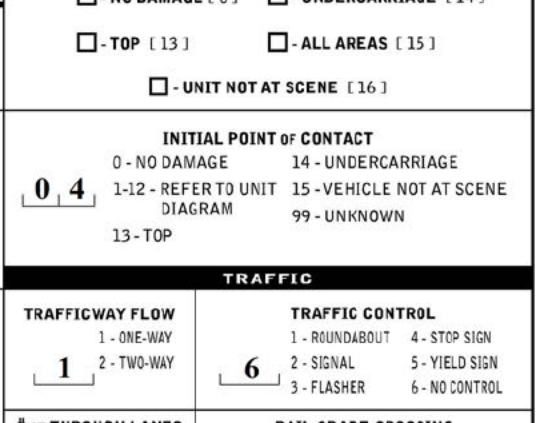
