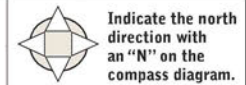

UNIT 1 HAD A GREEN LEFT ARROW AND PROCEEDED TO MAKE A LEFT TURN ON TO MOGADORE RD. UNIT 2 FAILED TO STOP AT THE RED AND STRUCK UNIT 1. UNIT 2 WENT OFF THE RIGHT SIDE OF THE ROAD AND STRUCK THE TRAFFIC CONTROL BOX AND ENDED UP IN THE DITCH ROADSIDE.**

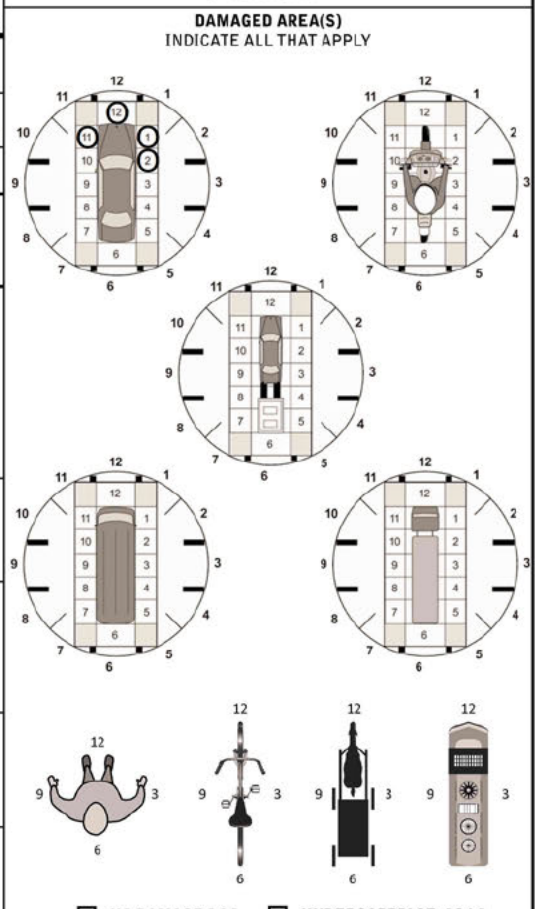
