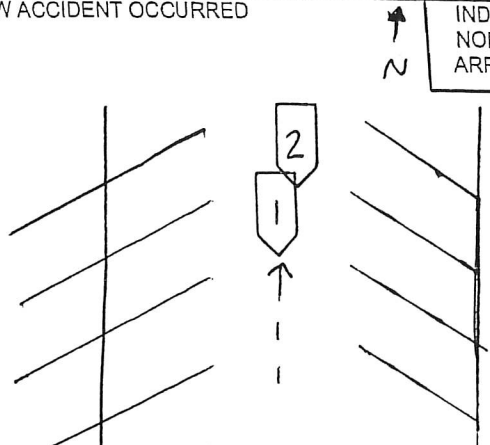
DESCRIBE HOW ACCIDENT OCCURRED
