ORDINANCE NO. 2025 - 054

AN ORDINANCE AMENDING ORDINANCE NO. 2024-127 THE POSITION ALLOCATION AND AFSCME CONTRACT, AND DECLARING AN EMERGENCY.

WHEREAS, the City has changes to the Position Allocation and AFSCME union contract as follows:

a) Remove the position of Maintenance Worker/Carpenter; and

b) Add one additional Repair Operator position which would bring the total Number of Repair Operators from three (3) to four (4)

WHEREAS, there is no financial impact to this request for the removal and addition of positions because they are in the same wage classification; and

WHEREAS, time is of the essence to make these updates to the Position Allocation and the AFSCME Contract.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio:

<u>SECTION 1</u>. That Council does hereby approve an amendment to the 2024 Position Allocation Ordinance, 2024-127, passed December 18, 2024, to update the Position Allocation and the AFSCME Contract, as set forth in Exhibit A, attached hereto and incorporated herein.

SECTION 2. That all existing ordinances which are in conflict with the provisions of this ordinance are hereby REPEALED.

<u>SECTION 3</u>. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

SECTION 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
