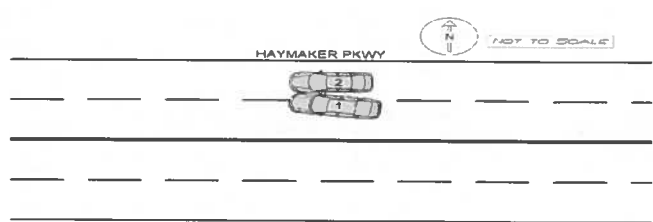
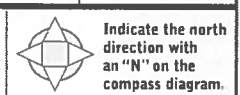

**UNIT 1 WAS TRAVELING WESTBOUND ON HAYMAKER PKWY APPROXIMATELY 200 YARDS EAST OF RIVER ST IN THE CENTER LANE ALONGSIDE UNIT 2, WHICH WAS ALSO TRAVELING WESTBOUND ON HAYMAKER PKWY IN THE CURB LANE. UNIT 1 MADE AN UNSAFE LANE CHANGE, ENTERED THE LANE UNIT 2 WAS OCCUPYING, AND STRUCK UNIT 2.**

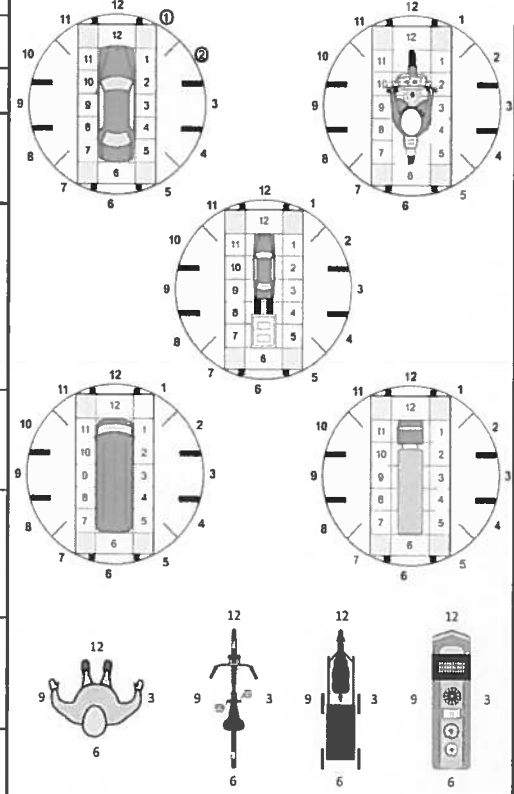
