## **JOINT RESOLUTION NO. 2023 -025**

A JOINT RESOLUTION APPOINTING GLENN RUSSELL, A MEMBER OF FRANKLIN TOWNSHIP TRUSTEES, TO THE STANDING ROCK CEMETERY BOARD OF TRUSTEES, IN ACCORDANCE WITH THE PROVISIONS OF THE OHIO REVISED CODE SECTION 759.36, EFFECTIVE JANUARY 1, 2024 AND ENDING DECEMBER 31, 2026, AND DECLARING AN EMERGENCY.
