**A JOINT RESOLUTION GRANTING SALARY AND HOURLY PAY RAISES TO THE PERSONNEL OF THE STANDING ROCK CEMETERY, AND DECLARING AN EMERGENCY.**

**NOW, THEREFORE BE IT RESOLVED** by the Council of the City of Kent, Portage County, Ohio and the Board of Trustees of Franklin Township, Ohio, meeting jointly, at least a majority of all members elected thereto concurring:

**SECTION 1.** That the salary and hourly pay rates of the Standing Rock Cemetery are as set forth below:
