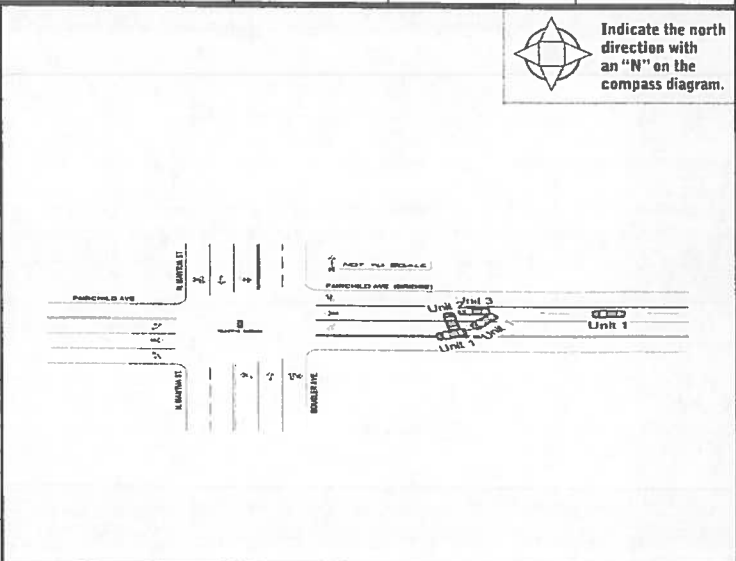

UNIT 2 AND UNIT 3 NEVER MADE CONTACT. UNIT 1 SWERVED TO AVOID UNIT 2 AND UNIT 3. UNIT 3 REPORTED UNIT 1 STRUCK HER. UNIT 1 THEN SWERVED LEFT OF CENTER TO AVOID THE OTHER VEHICLES AND STRUCK UNIT 2.**
