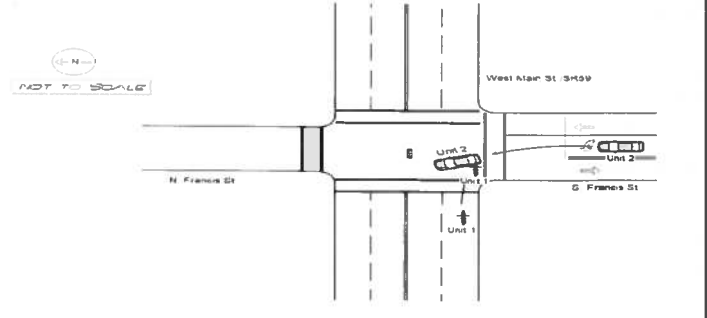
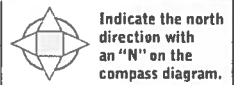

NARRATIVE

Unit one was traveling east on W. Main(SR59), approaching S. Francis. Unit two was traveling north on S. Francis at W. Main and was struck by unit one. Unit one attempted to avoid the crash by maneuvering to the right around Unit two; however, Unit one struck Unit Two's rear tire and quarter panel. The occupants of the motorcycle remained with the motorcycle, striking the roadway. The only injury was to the operator's arm, abrasion and he refused medical treatment.

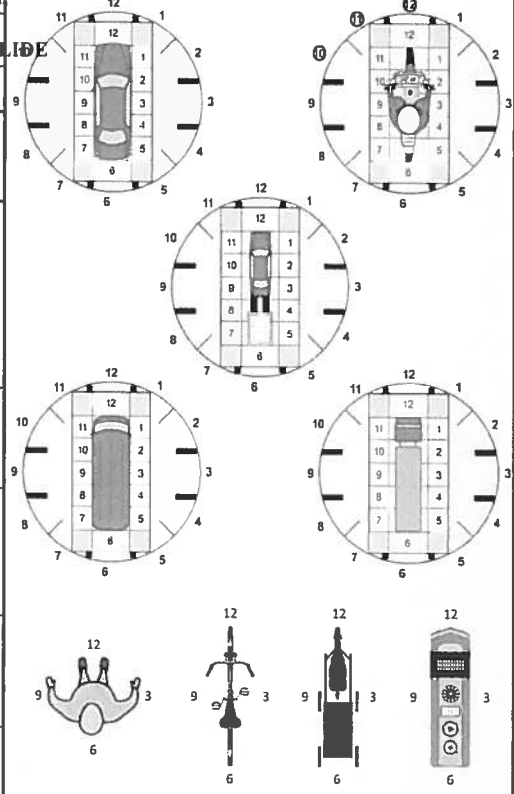

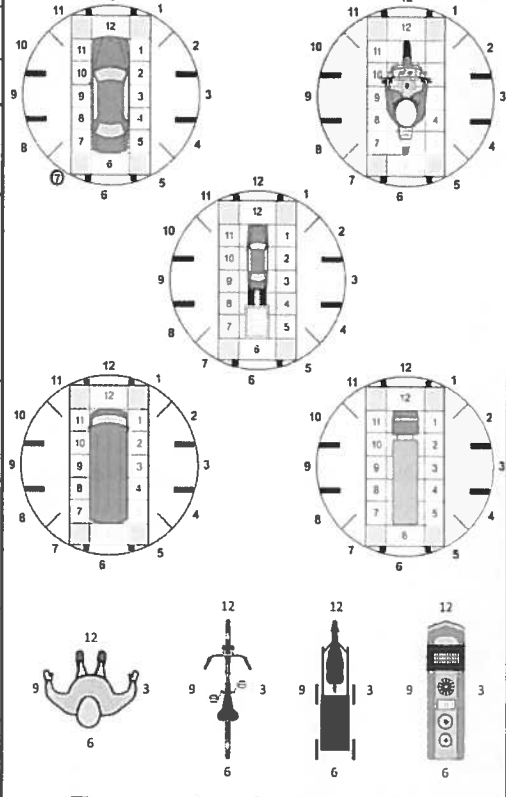
