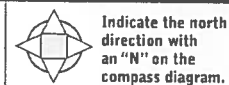

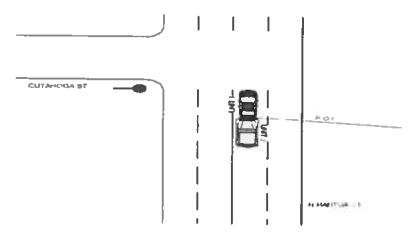
NARRATIVE

Unit 1 was stopped in the left hand northbound lane of N Mantua ST waiting on another vehicle to turn onto Cuyahoga St. Unit 2 was traveling from south to north on N Mantua St. The driver of Unit 2 was unable to stop in time and slid into the rear end of Unit 1.

No injuries were reported. Unit 1 had a small amount of paint transfer on the rear bumper, while Unit 2 had no apparent damage.

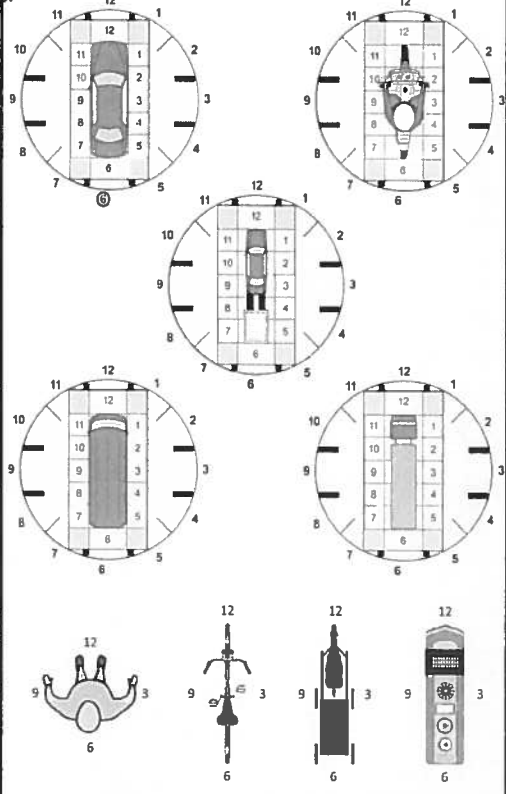

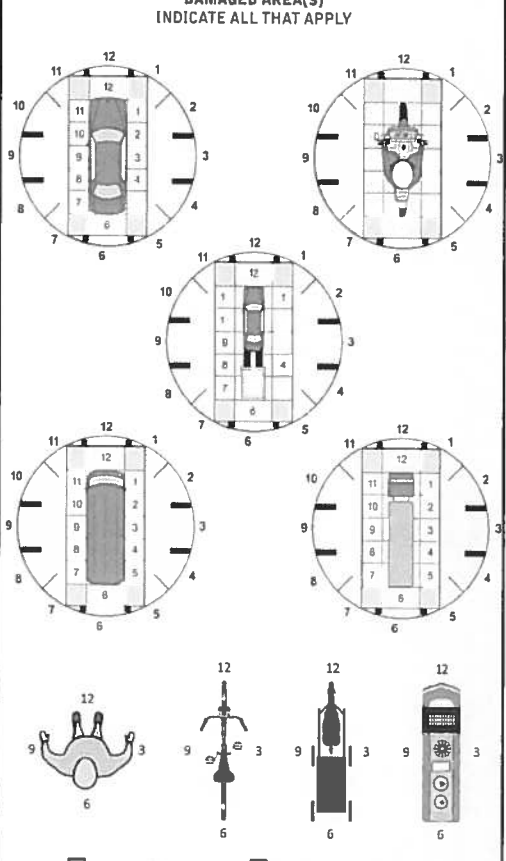
